Monthly comment

The Fund rose 5.39% in February, compared to a 2.60% gain for the benchmark index. US stocks performed the best - they rose 8.5%. Thai stocks added 3.5%. Japanese and Singapore stocks lost less than 1%. Currencies were a headwind for the Fund as both the Japanese Yen and the Thai Baht depreciated by 1.5% against the US dollar.

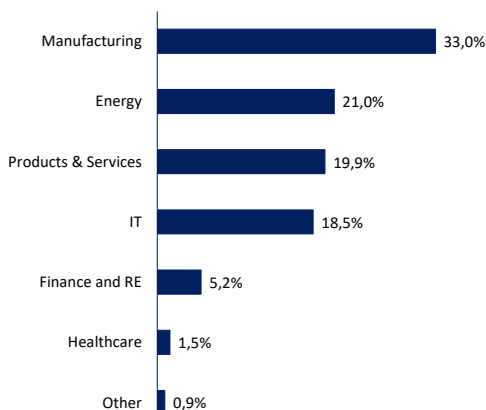

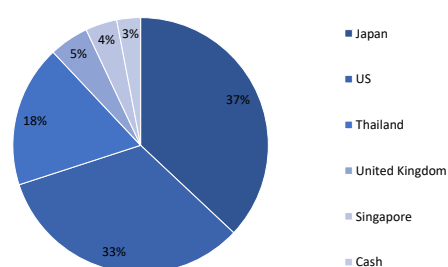
